Dear Central Hudson Customer,

We had previously written to you regarding a project taking place in your neighborhood to replace the natural gas mains in the street and service lines that connect individual homes and businesses. As the outbreak of the Coronavirus COVID-19 impacts our communities, we are modifying this work in order to maintain the safety and health of our customers, contractors and employees.

If the service line to your home or building is affected, J. Mullen & Sons, Inc. will contact you to schedule an appointment for its replacement. ***During the pandemic, all work related to this activity will take place outdoors only.*** In the future, when health officials and the Center for Disease Control provide clearance, our representatives will contact you again to schedule the indoor work. At that time, the new service line will be connected to your home or building, and any indoor work will be completed. Also, when cleared to do so by health officials, natural gas meters located indoors will be relocated by Central Hudson or one of our contractors to an outdoor location to improve future access to this equipment by utility personnel. All indoor work will be scheduled and completed only after health officials have provided general clearance to do so.

Any disruptions to your property will be restored by our crews or our professional landscape and paving contractors. If you do not own the home or property, please refer all decisions concerning this work to the property owner.

This work is being performed to improve the safety, reliability, and performance of our natural gas distribution system. Dear Central Hudson Customer,

In an effort to improve the safety, reliability, and performance of our natural gas distribution system, Central Hudson has undertaken a comprehensive natural gas main and service replacement program in select communities throughout the Hudson Valley.

As part of this improvement initiative, Central Hudson will be investing in the natural gas system in your neighborhood by replacing the main lines in the street and service lines that connect to individual homes and businesses. Central Hudson is working with our construction partner, J. Mullen & Sons, Inc., to install these new natural gas distribution mains and services.

Replacement of approximately 2,400 feet of gas lines in the City of Kingston is formally set to begin in March and the project is estimated to take 3 months to complete. Construction trenching will occur along:

- Mary's Ave, between Hoffman St and W Chester St

If your service line is affected, J. Mullen & Sons, Inc. will contact you in the upcoming weeks to schedule an appointment for your replacement. Natural gas meters currently located indoors will be relocated by Central Hudson or one of our contractors to an outdoor location to improve future access to this equipment by utility personnel. For your safety and security, all Central Hudson personnel and contractors wear and display identification badges.

Please note that this entire process may require work to be performed both inside and outside of your home or business. Any disruptions to your property will be restored by our crews
