Dear Central Hudson Customer,

As an essential provider, Central Hudson maintains critical energy services to our customers, all while continuing to follow COVID-19 safety guidance. As a part of this commitment, Central Hudson is undertaking a comprehensive natural gas main and service replacement program in select communities throughout the Mid-Hudson Valley to address and modernize aging infrastructure. This initiative is part of an effort to improve the safety, reliability and performance of the natural gas distribution system.

We are planning to invest in the natural gas system in your neighborhood by replacing the main lines in the street and service lines that connect to individual homes and businesses. This work will follow health and safety protocols established by health officials.

Central Hudson is working with our construction partner, J. Mullen & Sons, Inc., to install these new natural gas distribution mains and services. Replacement of approximately 10,200 feet of gas lines in the Village of Saugerties is formally set to begin in April and the project is estimated to take 4 months to complete. Construction trenching will occur along:

- Partition St, between Main St and Montgomery St
- Russell St, between Partition St and Washington Ave
- Post St, between Partition St and Cedar St
- Clermont St, between Partition St and Washington Ave
- Washington Ave, between Division St and Clermont St
- Division St, between Center St and Cedar St
- Center St
- Cedar St, between Main St and Division St
- Malden Ave, between Sawyer Kill Ter
- Finger St, between Bennett Ave and Malden Ave
- Virginia Ave, between Bennett Ave and Finger St

If your service line is affected, J. Mullen & Sons, Inc. will contact you to schedule an appointment for its replacement. Please note that this entire process requires work to be performed

Indoor work will be conducted by trained professionals following current COVID-19 protocols. All Central Hudson employees and contractors display identification badges.

Any disruptions to your property will be restored by our crews or our professional landscape and paving contractors. If you do not own the home or property, please refer all decisions concerning this work to the property owner.

Central Hudson is working closely with your municipal officials in planning this work, such as coordination with paving, restoration, and other planned infrastructure projects. 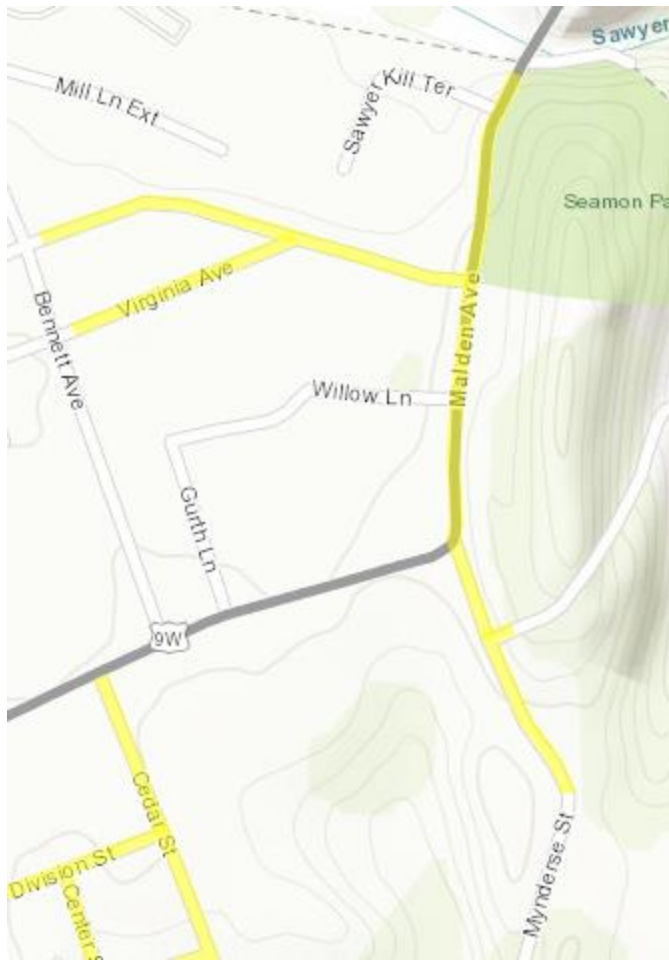

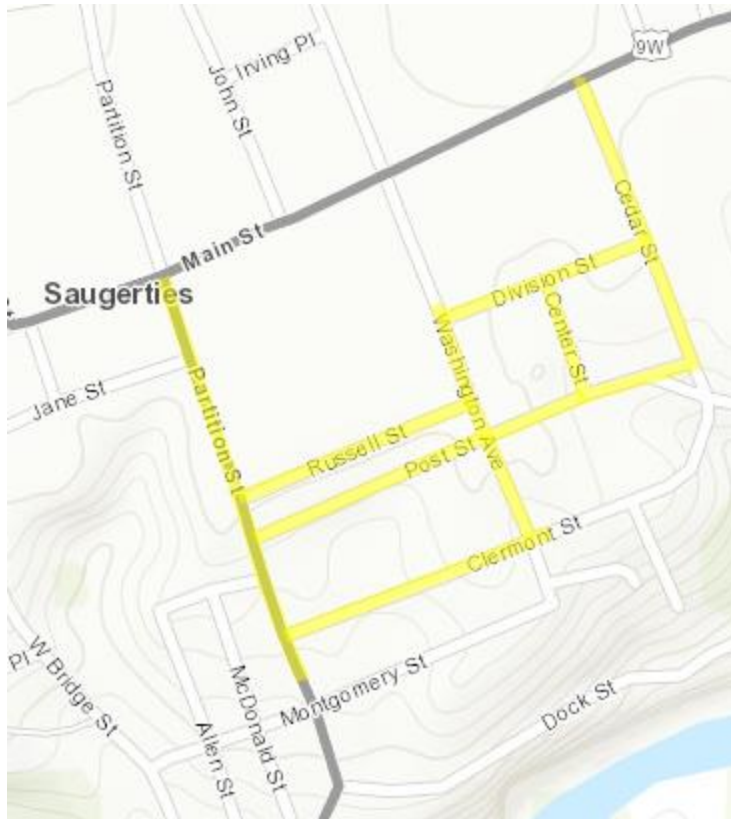
